

Respond.Health Terms of Use Agreement

Effective Date: 10/11/2024

Below are the terms that apply to the online products and services owned and operated by My Own Med, Inc., dba RespondHealth (“[RespondHealth](#)”), as part of the respond.health ecosystem, including our websites and mobile applications (collectively, the “[Platform](#)”). This Terms of Use Agreement (“[Agreement](#)”) informs Visitors of the rules and policies that govern the Platform. We use the term “Visitors” to include both registered users of the Platform and any other person that accesses the Platform at any point for any amount of time, unless designated otherwise. Visitors are expected to follow any posted guidelines or rules, including this Agreement.

Please carefully read this Agreement. We may update this Agreement from time to time without notice. Any changes to this Agreement will be incorporated into a revised Agreement that we will post on the Website. All visitors have the obligation to review changes to this Agreement, including any changes to our Privacy Policy, which is available at [Privacy Policy – Respond.Health](#). Unless otherwise specified, such changes shall be effective when they are posted. Your access or use of the Platform constitutes your agreement to be bound by this Agreement, including any changes that exist when you re-access the Platform. IF YOU DO NOT AGREE WITH THE TERMS OF THIS AGREEMENT, OR ANY POSTED GUIDELINES OR RULES, THEN DO NOT USE THE PLATFORM.

To participate in activities on the Platform, we may request that you submit certain personally identifiable information about yourself, including health and medication information (“Personal Information”). When you create an Account (as defined below) we may collect Personal Information directly from your physicians or other providers. We may also gather certain types of non-personal information about your visit to protect the security of Platform visitors or the Platform or to make the content of the Platform more useful and enjoyable for all our visitors. All information gathered from visitors by the Platform will be governed by our Privacy Policy located at [Privacy Policy – Respond.Health](#), which is incorporated in this Terms of Use Agreement by reference. If there is a conflict between the terms of this Agreement and our Privacy Policy, the terms of the Privacy Policy will prevail. Please carefully review our Privacy Policy to understand our collection, use, and disclosure practices.

Visitors are responsible for providing accurate, timely, and complete information to us and our operational providers, agents, and affiliates in connection with a visitor's participation and/or use of the Platform. Your participation in the Platform's activities may be canceled without notice if, at any time, we discover that you provide false information or violate any term of this Agreement or our Privacy Policy. The Platform and RespondHealth are not liable or responsible for any claims relating to any inaccurate, untimely, false, or incomplete information provided to us or resulting from a visitor's failure to fully comply with any provision of this Agreement. If necessary, and in accordance with applicable law, the Platform and RespondHealth will cooperate with local, state, and/or federal authorities to protect the Platform or RespondHealth or to prevent unauthorized use of the Platform or any content included on the Website or Application.

Content for Patient Education Purposes Only

Reliance on any Patient Content is solely at your own risk.

Registration and Participation

Registration with the Platform may be required in order to access certain services, including, without limitation, the creation of a Respond.Health Account (“Account”) or participation in certain interactive features of the Platform. Your registration information will be handled by us in accordance with our Privacy Policy, which you should review prior to registering with us.

You are responsible for maintaining the confidentiality of your password and any membership Account information. You agree to immediately notify us of any unauthorized use of your password or other membership Account information and further agree to indemnify and hold the Platform and RespondHealth harmless for any improper or illegal use of your password.

We encourage you to keep us informed about any changes in your personal contact and e-mail information if you have registered with the Platform. You may change, update, or delete certain information in your profile by contacting us. If your e-mail address is canceled or becomes inactive or inaccessible for an extended period of time, we may cancel your registration and delete all or part of your Account, to the extent allowed by law and in accordance with our security measures. We also reserve the right to suspend or terminate your Account if you violate any provision of this Agreement or our Privacy Policy, or for any other behavior that we, in our sole discretion, believe is inappropriate.

Ability to Share Information You Submit and Create Shared Accounts

The Application may offer functionality that allows you to (a) view an Account created by another person for whom you act as a personal representative; (b) have your personal representative view an Account you created; and/or (c) create a shared Account on behalf of a family member or other person for whom you act as a personal representative with that person’s permission that can be accessed by you and the person for whom the Account was created.

You and your physicians and other providers may be able to view and edit your Personal Information. You may also choose to share your Account with your personal representative. If you chose to share your Account with your personal representative, including caregivers or family, you can view a list of who has access to your Account. You agree that any person to whom you grant access to your Account is your personal representative and is authorized by you to access all Personal Information and other information in your Account. The individuals who have access to your Account may view but may not edit your information. Your provision of access to your Account by others may result in third parties misusing the Personal Information in your Account and is at your own risk. At any time you can take away someone’s ability to access your Account, and that person will no longer be able to view your Personal Information, but they may have already seen or may retain a copy of the Personal Information contained

in your Account. If you use the Application to create an Account on behalf of another person who is not your minor child, you represent, warrant and covenant that you have that person's permission and authorization to create an Account on his or her behalf and are properly authorized to serve as personal representative for that person under applicable laws. Further, you agree that you will not create an account for any minor that has not reached the age of majority in your jurisdiction, unless he/she is your own child, or you are the child's legal guardian. If at any time you no longer have the permission of that person to operate an Account on his or her behalf, you agree to immediately delete that Account. If you are having a medical emergency, DO NOT use the Platform to communicate with other individuals.

Restrictions on Visitors' Use of Website Content

The Platform contains materials supplied by the Website, Application, RespondHealth, and the Platform's visitors, as well as other sources, and is protected by copyrights, trademarks, service marks, patents, trade secrets, or other proprietary rights and laws.
